The registration information will be scanned in at the Check-In, where they will determine whether a loading zone is available for you. As soon as a loading zone becomes available, you will be given an authorisation form allowing your</p>		<p>We provide parking spaces for a fee for cars with a gross vehicle weight rating of up to 2.5 t and for car trailers. Please use the Shop for Exhibitor Services (www.serviceshop.messefrankfurt.com) to make your reservations by no later than four weeks before the start of the event. It may not be possible to honour orders made after this time.</p> <p>Truck parking spaces</p>

<p>Advanced set-up 13 – 15 April</p> <p>Advanced set-up must be ordered from the Shop for Exhibitor Services (www.serviceshop.messefrankfurt.com). Advanced set-up is subject to a charge.</p> <p>back</p>		<p>Deliveries during trade fair 21 – 23 April</p> <p>For deliveries, vehicles will be granted entry via the gate closest to the exhibition hall for one hour in return for a deposit of €100.00. All other vehicles will only be allowed to enter with a valid parking permit.</p> <p>back</p> <p>Last day of the trade fair 24 April</p> <ul style="list-style-type: none">• Entry will not be permitted after 2 p.m.• From 2 p.m. until the start of admission for dismantling vehicles, no vehicles will be allowed to enter the exhibition grounds• Please head to the E1 assembly point at the Rebstock car park. This is the only place where you can obtain a dismantling vehicle pass. <p>back</p> <p>Admission for special dismantling vehicles 24 April, 5 – 7 p.m.</p> <p>for exhibitors, for the transport of smaller loads by cars and vans up to 3.5 t gross vehicle weight rating. Pre-ordering is not possible, but a max. of 400 of these special permits are issued. Therefore, you should take care of it early: 20. – 24.4., 10 a.m. to 2 p.m. at the Central Information Desk on Level 02 of the Torhaus.</p> <p>At the counter you must</p> <ul style="list-style-type: none">• state and prove your exhibitor customer number• present your valid exhibitor pass• sign a declaration of assumption of costs for EUR 250 (this will be offset against the invoice for ancillary costs if you leave the exhibition centre after 8 p.m.) <p>Please note that you will not be able to use the goods lifts.</p> <p>back</p>	
<p>Set-up 16 – 20 April</p> <p>Registration required.</p> <p>All vehicles must depart the exhibition grounds as soon as they have been unloaded/loaded. Vehicles that stay longer than permitted may be towed away at the owner’s expense</p> <p>For a deposit of € 100 in cash, you can also drive for 1 hour directly to the loading zones of the exhibition halls.</p> <p>Please note that the aisles must be clear from 3 p.m. on 20 April. After that, set-up is only possible within the stands.</p> <p>back</p>		<p>General admission for dismantling vehicles 24 April after 8 p.m.</p> <p>Please drive your dismantling vehicles straight to the designated dismantling assembly point at the Rebstock car park. This is the only place you can receive your dismantling vehicle pass to enter the exhibition grounds, and it is the only place where police will permit and direct entry starting after 8 p.m.</p> <p>Access from other streets will not be granted until all of the vehicles from this area have already entered the exhibition grounds. It is only after this has occurred that cars from the car parks on the exhibition grounds will also be permitted to drive to the halls.</p> <p>Please note: No registration is required for the last day of the trade fair and the dismantling entrance.</p> <p>back</p> <p>Dismantling 25 – 26 April</p> <p>Registration required.</p> <p>Dismantling ends at 9 p.m. on 26 April 2026.</p> <p>back</p> <p>Extended dismantling 27 April</p> <p>Extended dismantling must be ordered from the Shop for Exhibitor Services (www.serviceshop.messefrankfurt.com) and is not possible in every hall. Advanced set-up is free of charge.</p> <p>Extended Dismantling ends at 8 p.m. on 27 April 2026.</p> <p>back</p>
