### Registration during set-up and dismantling

Exhibitors, stand construction companies and freight forwarders must register in advance online, allowing them to easily download and print their own registration confirmation form. You can drive to the specified Check-In with this registration confirmation form. Please follow the signs. The registration information will be scanned in at the Check-In, where they will determine whether a loading zone is available for you. As soon as a loading zone becomes available, you will be given an authorisation form allowing your vehicle to enter the exhibition grounds, along with the gate through which you should enter. **Please note: In case of high volume of traffic waiting times are possible at the Check-In!** All vehicles must depart the exhibition grounds as soon as they have been unloaded/loaded. Vehicles that stay longer than permitted may be towed away at the owner's expense. [back](#)

### Advanced set-up 24 - 25 March 2020

Advanced set-up must be ordered from the Shop for Exhibitor Services. Advanced set-up is free of charge until the ordering deadline. After the deadline the costs are 250 € per stand and day.

Please note that it is not possible to register vehicles until confirmation for advanced set-up has been received. [back](#)

### Car parking spaces

We provide parking spaces for a fee for cars with a gross vehicle weight rating of up to 2.5 t. Please use the Shop for Exhibitor Services to make your reservations by no later than six weeks before the start of the event. It may not be possible to honour orders made after this time. We provide parking spaces on the exhibition grounds for car trailers for a fee. These must also be ordered through the Shop for Exhibitor Services by no later than six weeks before the start of the event.

### Truck parking spaces

You may park your vehicle for set-up/dismantling at the Rebstock E1 truck park for a fee for general dismantling activities between 29 March and 03 April 2020. Reservations are not required. [back](#)

### Trade fair 31 March - 02 April 2020

For deliveries, vehicles will be granted entry via the gate closest to the exhibition hall for one hour in return for a deposit of €100.00. All other vehicles will only be allowed to enter with a valid parking permit. [back](#)

### Trade fair 03 April 2020 (last day of the trade fair)

On the last day of the trade fair, entry will not be permitted after 2:00 p.m. From 2:00 p.m. until the start of admission for dismantling vehicles, no vehicles will be allowed to enter the exhibition grounds. Dismantling vehicles should please head to the E1 assembly point at the Rebstock car park. This is the only place where you can obtain a dismantling vehicle pass.

On 03 April 2020 from 3:00 p.m. until 10:00 p.m. a free shuttle bus service will run between the Portalhaus entrance and Stop 4 (Haltepunkt 4) at the E1 truck assembly point at the Rebstock car park. [back](#)

### Admission for special dismantling vehicles on 03 April 2020 from 6:00 to 8:00 p.m

The trade fair ends at 6:00 p.m. on the final day of the event. On 03 April 2020 from 6:00 to 8:00 p.m., we offer you the opportunity to remove small items in advance of general admission for dismantling vehicles. We will be issuing a limited number of special dismantling vehicle passes for cars and vans up to 3.5 t gross vehicle weight rating during last two days of set-up and during the trade fair itself until all have been taken.

You can obtain these special dismantling vehicle passes at the Central Information Desk on Level 02 of the Torhaus by signing a declaration that you will be charged an additional €200.00 when invoiced for your ancillary costs if you do not leave the exhibition grounds with your vehicle by the deadline specified in the pass. Special dismantling vehicle passes will only be issued to exhibitors upon presentation of an exhibitor ID and customer number. The number of these passes is limited to a maximum of 400, so we recommend that you obtain yours as early as possible. They cannot be ordered in advance. The issue takes place from 29 March till 03 April 2020 between 10 a.m. and 2 p.m. Entry starting at 6:00 p.m. and departure by no later than 8:00 p.m. are only possible at the gate specified on the pass. If you leave the exhibition grounds with your vehicle by 8:00 p.m., you will not be charged for your special dismantling vehicle pass. For departures after 8:00 p.m., your pass serves as your receipt and we will include a €200.00 charge with your ancillary costs invoice. Please note that you will not be able to use the goods lifts due to the fact that the removal of the aisle carpeting from the exhibition halls and delivery of empty packing materials by the Logistics Service take place at the same time. ### General admission for dismantling vehicles on 03 April 2020 after 9:00 p.m.

Please drive your dismantling vehicles straight to the designated dismantling assembly point at the Rebstock car park. This is the only place you can receive your dismantling vehicle pass to enter the exhibition grounds, and it is the only place where police will permit and direct entry starting after 9:00 p.m. Access from other streets will not be granted until all of the vehicles from this area have already entered the exhibition grounds. It is only after this has occurred that cars from the car parks on the exhibition grounds will also be permitted to drive to the halls. [back](#)

### Dismantling 04 - 05 April 2020
